Press Release COVID-19 Death in Gallatin County

The Gallatin City-County Health Department is saddened to announce that one more Gallatin County resident has passed away from complications due to COVID-19.

This person was a male in his 80s who passed away at a hospital the week of February 27. Out of respect for this individual's family and friends, no further details will be released. This latest notification makes for a total of 118 COVID-related deaths in Gallatin County. In Gallatin County, 63% of eligible residents are fully vaccinated. For additional details on vaccine metadata, [click here](#). From April 1, 2021 to March 21, 2022, Gallatin County saw 585 hospitalizations who were positive for COVID-19. Of those, 450 individuals were unvaccinated or approximately 77%. From April 1, 2021 to March 18, 2022 statewide, [MT DPHHS reported](#) 1,644 deaths attributed to COVID-19. Of those deaths, 1,265 or 77% were unvaccinated.

Even with low case numbers, it is highly recommended you make a plan to stay up to date with your COVID-19 vaccine which includes any booster doses when you are [eligible](#), to help protect yourself and others. "Fully vaccinated" means a person has received the primary series of COVID-19 vaccines, and "up to date" means a person has received all recommended COVID-19 vaccines, including booster dose(s) when eligible. You can find your COVID-19 vaccine at local pharmacies, through your primary care physician, as well as clinics through the Gallatin City-County Health Department.
