Summary of MMWR Week 14 for the state of Montana:

- **Enteric Diseases:** Campylobacteriosis (5), Salmonellosis (2)
- **General Communicable Diseases:** Latent TB infection (LTBI) (2), Legionellosis (1)
- **Hepatitis:** Hepatitis B, chronic (3), Hepatitis C, chronic (14)
- **STD/HIV:** Chlamydia (101), Gonorrhea (22), Syphilis, primary or secondary (1)
- **Vaccine Preventable Diseases:** Influenza hospitalization or death (10), *Streptococcus pneumoniae*, invasive (1)
- **Zoonotic diseases:** Rabies, animal (1), Rabies, PEP (5)

COVID: To date, over 80 million cases of COVID-19, including at least 985,523 deaths, have been reported in the U.S. The percent of the eligible U.S. population 5+ with at least one vaccination is 82.1%. Montana is reporting 273,114 cases of COVID-19 as of 10:15 AM 04/15/2022. Of these, 11,856 individuals have been hospitalized and 3,260 have died. To date, Montana is reporting 1,439,785 total vaccine doses administered and processed into imMTrax. The total number of fully vaccinated persons is now 561,702. The percent of the eligible population that is fully vaccinated is 55%.

BA.2 Variant Update: DPHHS is monitoring sublineages of the Omicron variant, including BA.2. As of April 12, there have been 3,701 cases across Montana infected with Omicron variants—3,676 (99%) infected with BA.1/B.1.1.529 and 25 (1%) infected with BA.2.

INFLUENZA: activity **decreased** statewide from April 03 – 09, 2022, with 151 new cases reported during week 14. Season to date, 5325 cases, 183 hospitalizations, and 6 deaths have been associated with influenza. Despite the decrease in influenza cases, 2 additional influenza-associated deaths were reported during week 14. Influenza A has been the dominant subtype circulating in Montana, with minimal Influenza B activity reported but present. Influenza-like illness (ILI) increased to 1.23%.
